My name is Kristi Dobbs. I am a Registered Dental Hygienist, wife and mother of 4. I was a healthy, active 39 year old before I received my one and only dose of the Pfizer covid 19 vaccine on January 18, 2021.

I had an immediate reaction at the hospital clinic where I was appointed. It started as an odd tingling sensation running through my left arm, where I had just received the shot. I had barely sat down in the monitoring station, when I suddenly had a pre-syncopal episode. I couldn't breath, felt hot, had increased pulse, respirations and heart rate, as well as a blood pressure reading that was so high it was stroke worthy. I was only monitored for 45 minutes, and then released once my blood pressure stabilized.

The next 2 days following my Pfizer vaccine, my symptoms included a sore arm, fatigue, swollen lymph nodes, and a headache. These are all the normal side effects I anticipated, and was given as informed consent.

However, on day 3 after the inoculation the effects of the vaccine started to ravage my body. I had a sharp stabbing pain in my left scapula region, as well as paresthesia's and tremors in my left arm and hand. By day 4 I was having full body tremors and paresthesia's, as well as an internal electrical vibration feeling, tinnitus, extreme fatigue, brain fog, muscle pain and weakness, inability to sleep, and multiple autonomic dysfunctions. I have had over 22 different symptoms that have plagued me for over 288 days.

I have taken over 20 different medications to help find a "cure" for my vaccine injury ailments. My medicine cabinet is littered with medicine bottles, but to date there has still been no medication that can ease the pain that has persisted in my body 24/7 for over 9 months.

To date I have seen over 15 different medical providers and specialists. Back in March I even had a tele-health visit with Dr. Nath's colleague Dr. Safavi at the NIH.

My vaccine injuries have been reported to Pfizer, VAERS, CDC, FDA, NIH, and other prominent research facilities.

I feel lucky that I was able to definitively know that my side effects were solely from the Pfizer vaccine. BUT...as I started doing research to find out more about these vaccine side effects, I found no answers. What I did find, however, were others that were injured not only by Pfizer, but Moderna, Jansen or Johnson and Johnson, Astra-Zenica, as well as other brands used over seas.

Our small group of vaccine injured started with an email thread of 4, but we were growing by the 10 fold each day. Soon we became so large that we knew we needed to

find a better platform to communicate. The only platform big enough for us to reach the thousands was social media. We knew we would be censored, we knew we would be written off as misinformation, but we were a lifeline to one another. We literally kept each other alive some days, because we had no answers, no hope, and no encouragement from others around us.

Husbands and wives were baffled as to why this happened to their spouse. Families were being discriminated against and segregated into the vaccinated and unvaccinated. Doctors were mystified and had no answer or cure. Specialist were no help either, with most of them dismissing our injuries for anxiety, panic attacks, and other mental health issues.

We have reached out to top officials at the CDC and FDA including Rachelle Walensky, Peter Marks, Janet Woodcock, and Paul Richards. We have also collaboratively sent letters to the White House, where we addressed the issue directly to President Joe Biden and Vice President Kamala Harris. They have ALL known about these covid 19 vaccine injuries since at LEAST early this year!

Because of the intentional suppression from these top agencies, the injured have been unable to get essential medical care, because the medical community is still uninformed of these vaccine reactions. There has been no funding or even willingness to do any research on these reactions. There is no treatment and there is clearly no recovery plan, or financial support in place either. We have been gas-lighted, silenced, abandoned, and cast aside as collateral damage.

We were told that these vaccine are "safe and effective" by world health leaders, prominent politicians, and renowned medical directors of this country. We were NOT given proper informed consent about the side effects of these vaccines, and were wrongfully coerced by the same leaders that were sworn to protect us.

We are living proof that these vaccines are not safe, nor effective.

I stand here today wearing purple. It is a blend of the primary colors red and blue. We want to prove to the world that this is not a political issue, it is an issue of humanity. We are bothers and sisters from both sides of the aisle, walking hand in hand to bring awareness to these vaccine injuries. Not just here in the US, but around the world.
